Explanation of Responses:

1. The reported shares represent a one-for-one exchange of the Issuer's Class C Common Stock to Class A Common Stock following the November 12, 2018 settlement date.
2. The shares of Class C Common Stock (i) confer no incidents of economic ownership on the holders thereof, (ii) only confer ten-to-one voting rights on the holders thereof, and (iii) may only be issued, on a one-for-one basis, to the Reporting Person and his associated entities who held LLC Units. Each share of Class C Common Stock and corresponding LLC Unit is exchangeable for one share of Class A Common Stock at the option of the holder (for which the Issuer may substitute cash) and has no expiration date. The Class C Common Stock is also convertible into Class B Common Stock on a one-for-one basis at the Reporting Person's election.
3. The reported shares were withheld to satisfy the Reporting Person's tax liability in connection with the vesting of RSUs.
4. Represent shares of Class C Common Stock exchanged on a one-for-one basis into shares of Class A Common Stock.

Remarks:

This Form 4 is being amended to reflect the exchange of 100,000 shares of Class C Common Stock into shares of Class A Common Stock, which was inadvertently omitted from the original Form 4, and to update the number of derivative securities beneficially owned accordingly.
